Mr. Abraham obtained an extraordinary writ from the California Court of Appeal dismissing the plaintiff's complaint without leave to amend in a data breach case in the healthcare industry in which there was a \$4 billion exposure for Mr. Abraham's client. *Sutter Health v. Superior Court* (2014) 227 Cal.App.4th 1546, review denied Oct. 16, 2014.

The California Court of Appeal adopted Mr. Abraham's analysis set forth in his Amicus Curiae brief resulting in a dismissal of plaintiff's data breach case against the Regents of California. *Regents of University of California v. Superior Court* (2013) 220 Cal.App.4th 549.
