ORDER GRANTING CO-TRUSTEES'
MOTION FOR COSTS AWARD

The Co-Trustees' motion for costs award is granted in the amount of \$99,239.89.

Overall. As the trustees point out, given the complexity, purported value and duration of this case, a costs award approaching \$100,000 is reasonable – that amount is some .04% of petitioner's requested recovery and 2% of the fees incurred by her counsel.

File & Serve and Chambers Costs. Our court requires File & Serve, so costs of it are recoverable. (CCP §1033.5(a)(14).) Likewise, the court requires delivery of courtesy copies to judges. (Local Rule 2.7(B).)

Deposition Travel Expenses. These are authorized by CCP §1033.5(a)(3) and may include airfare and lodging. (*Thon v. Thompson* (1994) 29 Cal.App.4th 1546, 1549.)

Trial Technician. Video display technology is essential in a modern trial – particularly one during a pandemic that saw the petitioner and witnesses appear remotely – and its cost is recoverable. (CCP §1033.5(c)(4); *Bender v. County of Los Angeles* (2013) 217 Cal.App.4th 968,

990-91; El Dorado Meat Co. v. Yosemite Meat & Locker Service, Inc. (2007) 150 Cal.App.4th 612, 620.) The trustees describe with specificity how these costs were reasonably incurred.

Trial Graphics. The court remembered the trial graphics and found them helpful. Their cost is recoverable under CCP §1033.5(a)(13).

Trial Exhibits. The hard copy exhibits were used extensively at trial and in preparing the statement of decision; their cost is recoverable. (CCP §1033.5(c)(4); *Benach v. County of Los Angeles* (2007) 149 Cal.App.4th 836, 855-57.)

Trial Transcript. The trial transcript was cited more than 600 times in the post-trial briefing; costs are recoverable under CCP §1033.5(c)(4).
